# Impose Sanctions on China for their Treatment of Practitioners of Falun Gong

“*Falun Gong is a traditional practice teaching truthfulness, compassion and tolerance. Falun Gong practitioners continue to face human rights violations in China. We urge the UK Government to oppose these violations by any effective means (e.g. Global Human Rights or Magnitsky-style sanctions).*”

*In 1999, about 100 million people were practising Falun Gong in China so Communist leader Jiang Zemin gave the order to eradicate it. Millions have been detained or imprisoned. Over 100,000 have been tortured or abused in custody, and thousands have been killed merely because of their faith.*

*In 2020 an Independent Tribunal, chaired by Sir Geoffrey Nice QC, concluded that Falun Gong practitioners were being killed for their organs in China and that this practice continues today.*

**Since 1999 the Chinese Communist Party (CCP) has been persecuting Falun Gong practitioners, subjecting them to all forms of inhumane treatment, including imprisonment, forced labour, torture and forced organ harvesting.**

“*The world is increasingly aware of China's forced organ harvesting from prisoners of conscience. This horrific crime of forcibly removing the organs from living victims—a process leading to inevitable murder—has recently been found by the China Tribunal to be happening extensively.*”

“*Forced organ harvesting is a terrible wrong. Innocent people are killed so that their organs can be transplanted into other people who are willing to pay. Clearly, the Chinese Communist Party bears ultimate responsibility for forced organ harvesting. It is the CCP which has sanctioned the persecution of victim groups and permitted the development of industrial scale organ transplantation in China.*”

*But we cannot let it rest there by saying that the CCP is responsible and they should stop. The victims of forced organ harvesting are our fellow human beings. They are owed the same basic regard for and protection of their rights that is owed to all human beings. As fellow human beings, we all have some responsibility to respond to their plight.*
